INVESTMENT OBJECTIVE

The State Farm Growth Fund (the "Fund" or the "Growth Fund") seeks long-term growth of capital, which may be supplemented by income.

INVESTMENT STRATEGY

Under normal circumstances the Fund invests at least 80% of its assets in equity securities. Equity securities include common stocks and other income-producing equity securities. While the Fund seeks to maintain sector weights consistent within 3% to 5% of each sector's weight in the S&P 500 Index, the Fund's benchmark, in making investment decisions on specific securities, the sub-adviser uses statistical modeling and research to look for companies with one or more of the following characteristics:

- •Strong profitability within their sector
- •Strong management efficiency
- •Strong cash flows within their sector
- •The ability to lower the volatility of the Fund

PORTFOLIO MANAGEMENT

State Farm Investment Management Corp. serves as the Fund's investment adviser. Northern Trust Investments, Inc. is the Fund's investment sub-adviser.

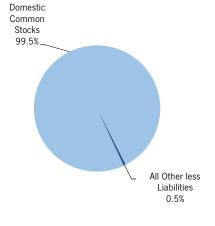
